

# Summer Day Camp Financial Policy 2024

## Payments, Discounts, & Refunds (ACTIVE and FACTS Sites)

**Summer Day Camp \$375 per week, July 4 week \$300** (deposit is subtracted from cost per week)

**Registration Fee \$75**

**Late Pick Up \$1 per minute after 6pm**

**Second Camp Shirt \$15**

**Cancellation/Transfer/Change Fee \$10**

**No Sign-Out Fee \$5 \***

Through ACTIVE, enroll by April 1<sup>st</sup> for a \$10/week **“early bird” discount**, and to ensure your child’s spot in your preferred weeks. Changes made after April 1<sup>st</sup> will no longer receive the early bird discount.

A weekly **deposit** of \$50 is due online through ACTIVE via credit card, at the time of enrollment to reserve a child’s space for each week of camp. A processing fee is included for all ACTIVE online payments. The processing fee of 6.95% for all online payments is charged by ACTIVE, and therefore this fee is non-refundable. An ACTIVE Advantage membership is not required to sign up for Kingdom Krew Summer Day Camp. All fees associated with this membership must be resolved directly with ACTIVE.

**All** families must be enrolled in FACTS, an online payment portal. The **weekly balance** is due on the Monday of each week of camp through FACTS. FACTS offers ACH transfer with no additional fee, or CC charge with a fee of 2.95%.

The \$75 **Registration Fee is non-refundable** and *will be charged on FACTS for all children who were not enrolled in the 2023-2024 school year.*

Please note that there will be **no cash or check** payments accepted in the office.

The **deposit** is refundable when canceled online by a parent by Thursday, June 6<sup>th</sup>, through your ACTIVE account. After June 6<sup>th</sup> deposits are nonrefundable but can be transferred with a \$10 fee, by contacting the office. The balance (cost of camp, less the deposit) is refundable, if canceled by Thursday at 6 p.m. before the week of camp. Refunds will be provided by check after the payment has completed processing.

Tuition remains the same whether or not your child attends. Tuition is not prorated for illness, injury, or vacation. This includes COVID related illness, symptoms or exposure. See Kingdom Krew COVID guidelines for more detail.

For **families utilizing a subsidy** for day camp payments, please enroll through ACTIVE for each week your child will attend. The \$50 per week deposit is due at the time of enrollment and will be applied to the balance due per week of camp. A refund for each week will be provided to the parent if there is a credit after the subsidy payment has been received and applied. ALL other financial policies are applicable.

\* It is a Licensing requirement that authorized adults sign children in and out each day. If children are not signed out this could result in a \$5 no sign-out fee.
